Course Description

Simulation of a design project experience through the completion and presentation of a comprehensive roadway project design. Students work in multi-disciplinary groups to complete a system design that includes roadway, traffic, materials, hydrologic/hydraulic, and geotechnical considerations. 3 credits.

Course Pre-Requisites / Co-Requisites

Senior standing.

Course Objectives

Expose students to the business of engineering design by participating on multidisciplinary teams in an actual design project with as realistic conditions as can be created in the classroom. This course intends to incorporate material learned from the relevant courses taken to date and use the science and engineering fundamentals along with the ability to communicate clearly about what is being done in solving a design problem. At this stage, the student should be able to perform the assigned design project in this class with little or no technical instruction.
